Veterans/Middle Income Housing Waiting List Open: Continuously

Berryland 1, 2 & 3 Bedrooms Units Rents range from: \$502-714*

N. 43rd/W. Kaul area

Northlawn 1, 2 & 3 Bedrooms Units Rents range from: \$504-723*

N. 20th/W. Villard area

Southlawn 1, 2 & 3 Bedroom Units Rents range from: \$499-716*

These apartment buildings are privately owned by the Housing Authority. The rents are not subsidized and no federal funding is received to operate these locations. Residents pay their own utilities.

To qualify for Veterans/Middle income housing in 2015, a family's household income **MUST BE AT LEAST**:

\$24,144 annually for a 1 Bedroom Unit (\$2,012 monthly)

\$29,424 annually for a 2 Bedroom Unit (\$2,452 monthly)

\$34,464 annually for a 3 Bedroom Unit (\$2,872 monthly)

The Housing Authority Board annually sets the rent structure and minimum income limits to qualify.
